President-Elect Deb Vance will automatically ascend to the position of President in 2027 and therefore will not appear on the ballot. Treasurer Tommy Sunn has one more year remaining of his 2-year term and therefore will not appear on the ballot. Local Directors Tracy Cummins and Gary Jones have one more year remaining on their terms and therefore will not appear on the ballot. Julie Wagner will serve as immediate past president in 2027 and therefore will not appear on the ballot.

As per Article XI, Section 4-Additional Candidates for the offices to be filled may be placed in nomination by petition signed by at least 20% of the REALTOR members eligible to vote. The petition must be filed with the Board Office Secretary at least two (2) weeks before the election. The election will take place at the October General Membership Meeting to be held on **Tuesday, October 13, 2026 at 11:00 a.m. at The Silver Palace in La Porte, Indiana**. Ballots will not be distributed until the vote is called and a picture ID may be required to receive a ballot. Only one ballot per eligible voting member. Members may stop by to vote at the meeting if they are unable to stay for the meeting, provided the vote has been called for and the final tally has not yet been completed.

Absentee Votes may be cast at the Board Office – 245 W Johnson Road, Suite 8, La Porte IN. Absentee Voting Schedule is as follows:

Wednesday, October 7, 2026 between 10:00 a.m. - 3 p.m.

Ballots will only be available at the Board Office and only one ballot per person will be allowed. Voting on behalf of another individual will not be permitted. Ballots will not be mailed, faxed, or emailed. Picture ID may be required for Absentee Voting.
