
# **Deserving Children Charity Updates**

#### 2025 Annual Broker Certification

Each September the association requires all member officers to certify agents in that officer per LPCAR Bylaws:

Article VI—Privileges and Obligations, Section 12. Certification by REALTOR®. "Designated" REALTOR® members of the association shall certify to the association during the month of September on a form provided by the association, a complete listing of all individuals licensed or certified in the REALTOR®'s office(s) and shall designate a primary association for each individual who holds membership. Designated REALTORS® shall also identify any non-member licensees in the REALTOR®'s office(s) and if designated REALTOR® dues have been paid to another association based on said non-member licensees, the designated REALTOR® shall identify the association to which dues have been remitted. These declarations shall be used for purposes of calculating dues under Article X, Section 2(a) of the Bylaws.

Each managing broker was sent out a form via email to complete and return by September 30, 2025. We ask that these forms be returned by the deadline. Thank you very much.
