


Our Golf Outing takes place

2019 REALTOR Dues Payments Move to Online Only

At the beginning of this year, we announced that for the 2019 dues billing cycle, the association would accept online payments only via the NAR e-Commerce system. This move allows for more security to our members since there will no longer be documentation at the board office, it will save on costs for documentation retention and/or removal, and it will allow a member to pay their dues from the convenience of their home or office.

When members log in to nar.realtor, they can pull up their invoice, see a "pay" button, then a checkout counter screen where they can enter credit card of electronic check information. The system validates payments in real time and send our association a report confirming payment. Members then have the option to print out receipt of their payment for their records.



In order to prepare for this upcoming dues billing cycle, members will need to create an account at www.nar.realtor if they have not already done so. If you have created an account, please make sure you are able to log into this account. This is also a great time to update any personal information that may have changed. Your association can change your office information as well as personal information, but members may also update information such as address, email and phone. In order to create an account, each member will need their NRDS number. If you are unsure of this number, please contact the this board office for the information. We are still a few months away so this is a great time to make sure you have your account set up and are able to log in to that account. A reminder, accepted forms of payment online are MasterCard, Visa and Electronic Check!

If anyone has any trouble creating an account, please stop by the board office! We will be happy to help you set up your account.
