## 2019 IAR Form Changes

#### The following legal forms had significant revisions and updates for 2019:

- Purchase Agreement (Improved Property)
- Purchase Agreement (Unimproved Property)
- Listing Contract (Exclusive Right to Sell) Improved Property
- Listing Contract (Exclusive Right to Sell) Unimproved Property
- Listing Contract (Exclusive Right to Lease)

The following changes were made for 2019:

- All forms which contained a \$ or "Dollars" now will say "U.S. Dollars." Reason: Emergence of Bitcoin and other currencies.
- All forms will now contain the phrase "For use only by members of the Indiana Association of REALTORS®" under the title of the form. Reason: To discourage use of IAR copyrighted forms by non-members.

### LPCAR Scholarships Available to Area Seniors/College Undergrads

The La Porte County Association of REALTORS is pleased to offer Scholarships in the amount of \$600 each to area seniors who plan on pursuing further education after graduation or are currently attending a college or trade school and who are related to a REALTOR or Affiliate member of LPCAR. (3 scholarships will be available in 2019—2 for high school seniors and 1 for a current college student.)

This award will be given to a

person demonstrating outstanding community involvement who is planning to pursue further education through an accredited college, university,

or trade school or are currently attending college or a trade school. Applications will be available in

February.

The application requires an essay of 200 words or less explaining why the scholarship should be awarded. Any application received without the es-

say will not be considered during the selection process. It is important for the student to complete all parts of the application The deadline and more details will be posted on our website toward the end of January.

Please have your student download the form once it is available. Students of family members of LPCAR (REALTOR and Affiliate Members) are eligible for this scholarship so we encourage them to apply as soon as possible.
