Our current President-Elect, Tracey Cummins will automatically ascend to the position of President in 2022 as per LPCAR Bylaws and therefore will not appear on the ballot. Our current Affiliate Director Julie Deal has one more year remaining on her term and therefore will not appear on the ballot.

As per Article XI, Section 4-Additional Candidates for the offices to be filled may be placed in nomination by petition signed by at least 20% of the REALTOR members eligible to vote. The petition must be filed with the Board Office Secretary at least two (2) weeks before the election. The election will take place at the October General Membership Meeting to be held on **Tuesday, October 12, 2021 at 11:30 a.m. at Portofino's Restaurant in La Porte, Indiana.** Ballots will not be distributed until the vote is called and a picture ID may be required to receive a ballot. Only one ballot per eligible voting member.

Ballots will only be available at the Board Office and only one ballot per person will be allowed. Voting on behalf of another individual will not be permitted. Ballots will not be mailed, faxed, or emailed. Picture ID will be required for Absentee Voting.
